## **FIRST RESPONDER COURSE**

**CLASS BEGINS:** Thursday, March 25, 2010  
**CLASS ENDS:** Thursday, April 29, 2010  
**CLASS MEETS:** Tuesday and Thursday evenings from 6:00 pm–10:00 pm and Sundays from 8:00am-4:00pm

Tuesday April 6; Thursday, April 8; Sunday April 11; Tuesday, April 13; Thursday, April 15;  
Tuesday, April 20; Thursday, April 22; Tuesday, April 27; and Thursday, April 29

**LOCATION:** Hartsville Fire Company, 1195 York Road, Warminster, PA 18974

**COST:** \$150.00 – includes FR textbook, FR workbook, CPR book and CPR certification

- Checks/money orders made payable to County of Bucks
- payment is due with pre-enrollment form–spots will not be held while waiting for payment
- this is the course fee regardless if you already have the books
- payment is not deposited until acceptance is confirmed and letters are sent

**ATTENDANCE REQUIREMENT:** Students are permitted to miss only 8 hours of class

### **MATERIALS NEEDED FOR CLASS – TO BE PURCHASED BY STUDENT:**

Blood Pressure Cuff, Stethoscope, Pocket Mask, Penlight – available through any medical supply company

**PREREQUISITES:** Must be 16 years of age prior to enrolling in the course. Anyone under 18 or in high school must submit the Parental Consent Form with the Pre-Enrollment Form (form can be found on our website)

### **COURSE INFORMATION:**

- \* Class size is limited, but must have a minimum of 15 registered students.
- \* Bucks County organizations have priority first, then Bucks County residents, followed by out-of-County organizations and then out-of-County residents.
- \* If you are affiliated with an organization, you must complete the section on the pre-enrollment form and it must be signed by the chief of the organization
- \* If you are not being sponsored by an organization, you must submit proof of health insurance (copy of card) WITH the pre-enrollment form.

### **A COMPLETED APPLICATION INCLUDES:**

1. Completed Pre-Enrollment Form – 2 pages
2. Payment – either check/money order made payable to County of Bucks or letter on organization letterhead saying they will be paying the course fee. Faxed applications will not be accepted to hold a spot while waiting for payment. Refunds are only given if student withdraws before the course begins.
3. Organization Supervisor Signature or copy of Health Insurance Card
4. Parental Consent Form – if under 18 or in high school
